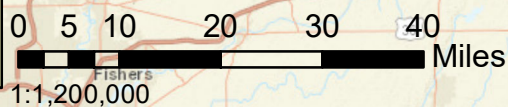
# Damage Prevention Coordinator Area by LOA and County
