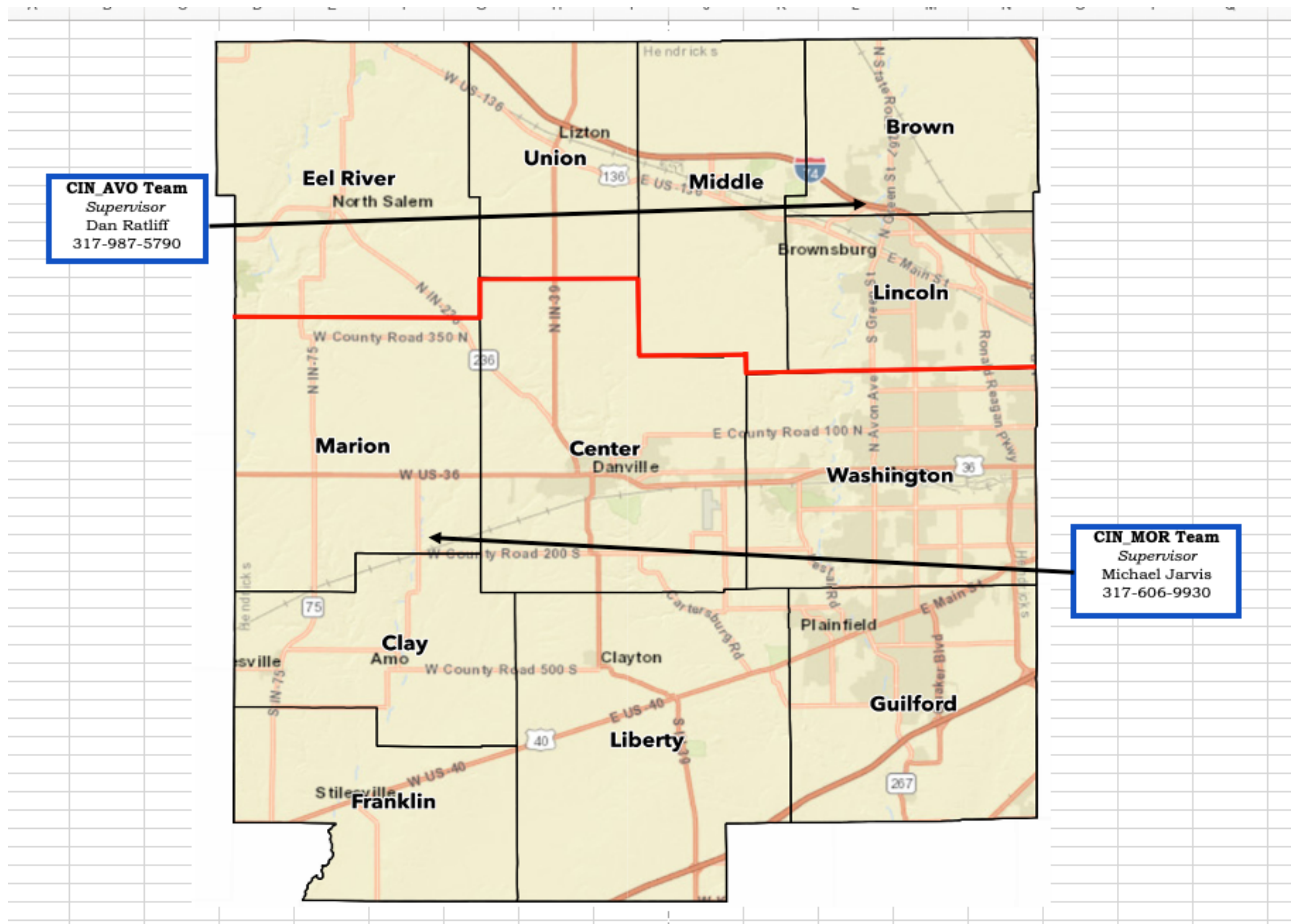
Detailed Hamilton County



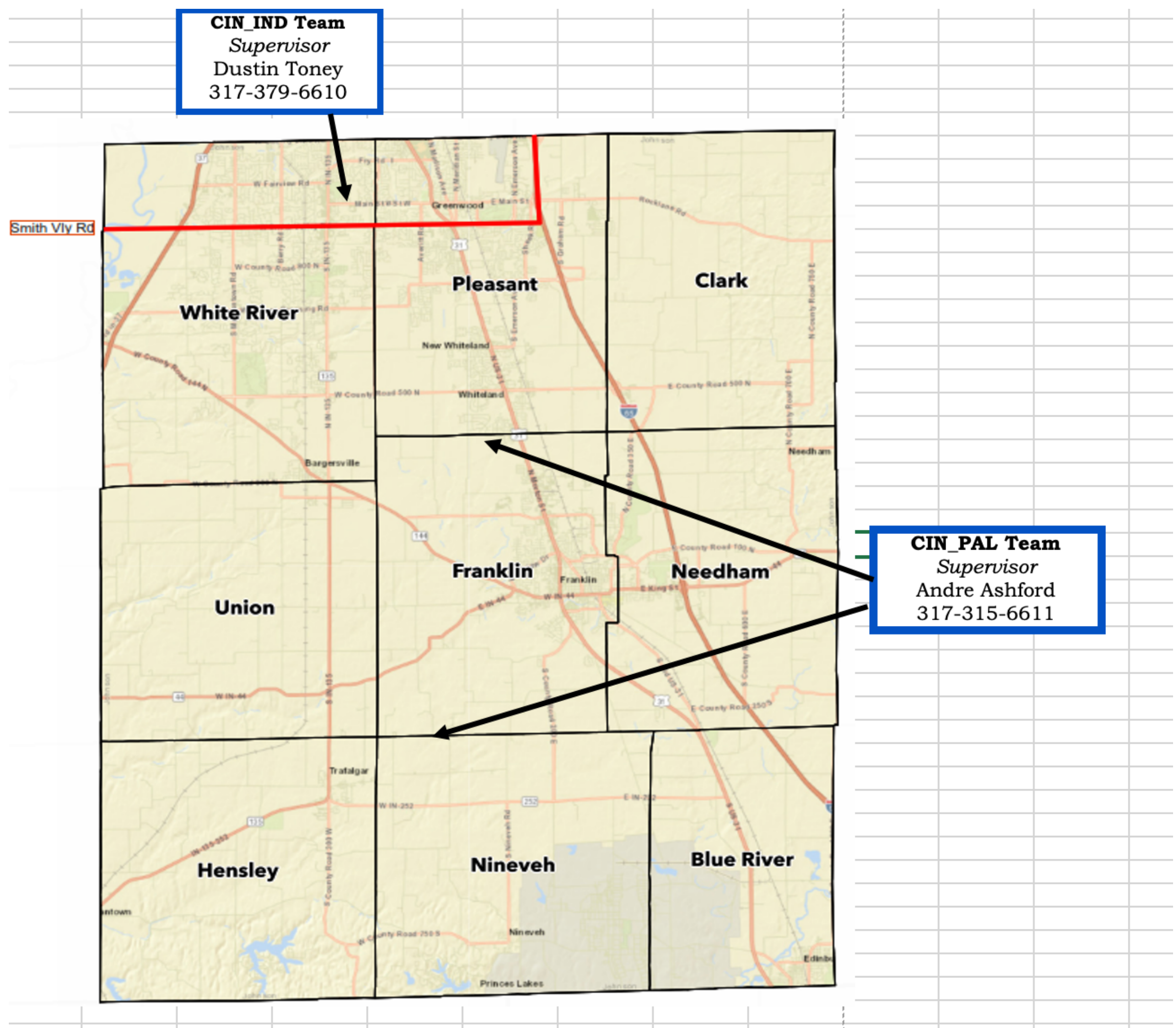
Detailed Hancock County



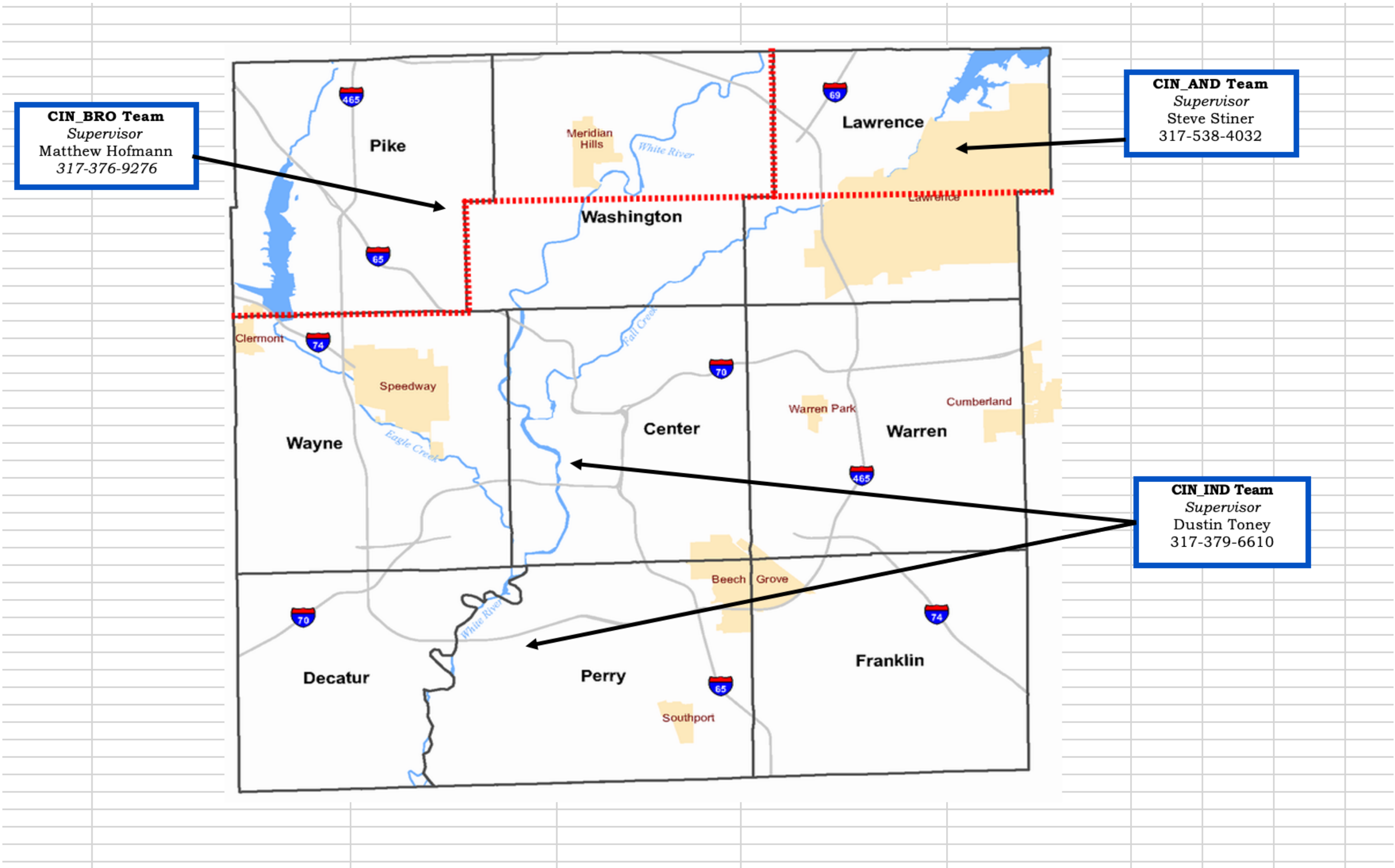
